2. Incentive and Penalty Provisions of ASRTU Contract (Clause No.17)

Dear Sir,

Kindly refer above cited provisions along with schedule annexure thereto, pertaining to our Rate Contract/Trial Rate Contract with the firms as per enclosed at Annexure.

Subsequent to the issue of Contracts, ASRTU has made all the efforts to recover the dues ASRTU Rebate from these firms, for which the firms did not respond.


Therefore, as per the provisions of ASRTU contract, clause no.17 (c ) vi, vii & viii, the Rate Contract / Trial Rate Contract of these firms are being converted into **Provisional Rate Contract w.e.f. 01.10.2024** or till receipt of full and final payment of ASRTU rebate, whichever is earlier.

If, however, any firm fails to clear the payment of ASRTU rebate up to quarter ending 30/09/2024 on before 31/12/2024 the **Provisional Contract** of the firm will be **suspended w.e.f.01.01.2025**.
